

Implementation of Electronic Lodgment for Instruments for Private Properties

I had previously informed you (in Dec 2004) that mandatory electronic lodgment of instruments will commence in July 2005. This was to give you sufficient time to familiarise yourself with e-lodgment before making it mandatory.

2 Since then, I have received feedback that many of you are still not ready to elodge your documents despite the 6-months lead time. Nevertheless, I am prepared to further extend the voluntary period for e-lodgment to 31 Dec 2005. During this time, you can continue to lodge your documents either over-the-counter or electronically using the STARS e-lodgment system (ELS).

3 I am pleased to inform you that another 37 e-forms will be made available for e-lodgment effective 1 July 2005. They are listed at Annex. This means that there will be 80 applications that you can lodge electronically.

An updated version of the offline preparation software will be available at <u>http://www.stars.gov.sg</u> as from 1 Jul 2005.

5 I would strongly encourage you to use the system as much as possible during this period so as to familiarise yourself with ELS and the e-forms.
