

<u>Implementation of Electronic Lodgment for Instruments for Private Properties</u>

New Service

I am pleased to announce another new service initiative to serve you and your clients better. Effective 30 Sep 2005, you will be able to search the law firm to which a title document was delivered upon registration of an instrument lodged electronically using STARS eLodgment system. You can simply access the function "Enquire Title Document Collection Details" (whether or not you were the lodging party).

Forms Available for eLodgment

I am also pleased to inform you that a further 26 forms as listed in **Annex A** will be available for electronic lodgment as from 30 Sep 2005.

An updated version of the offline preparation software will be available for download from this date from the STARS elodgment website (http://www.stars.gov.sg).

With this, a total of 98 instrument/forms will be available for electronic lodgment. Please refer to **Annex B** for a complete list.

Extension of Deadline

In my 24 May 2005 announcement, I had informed you that the Registrar will continue to accept both electronic and manual lodgment of instruments until 31 Dec 2005. I have decided to grant a final extension to 17 Jan 2006. Effective **18 Jan 2006**, **only** electronic lodgment of instruments listed in **Annex B** will be accepted for registration. Such instruments which are not executed prior to 18 Jan 2006 will not be accepted for registration if lodged manually.

I strongly urge you to use the system as much as possible during this period so as to familiarise yourself with the system and the electronic forms. I regret that there will be no further deadline extensions as sufficient notice has been given.

Training

For those of you who wish to obtain formal training in a classroom setting with hands on experience, arrangements have been made with the Singapore Academy of Law (LawNet Training Centre) to conduct training classes on STARS eLodgment System commencing Oct 2005.
