**CS NOTICE: QUERY-FREE RATE ON CADASTRAL JOBS SUBMITTED BY REGISTERED SURVEYORS (MONTH OF JAN 2008)**

The statistics in previous CS Notices on query rate for Registered Surveyors' jobs were based on a combination of query and clarification. With the implementation of the new list and criteria for query / clarification vide CS Circular No. 7/2007, the query and clarification cases are compiled separately. In line with this implementation, we have reviewed the compilation of query jobs for the CS Notices. With effect from Jan 2008, it will be based on query-free rate. Query-free jobs are jobs which have no query raised. [Note: Para 3 of CS Circular No. 7/2007 defines 5 clarifications as equivalent to 1 query. This definition applies herein to define whether a job is query-free or with query. In short, a job with 5 or more clarification is not a query-free job.] Annex A shows the query-free rate for Jan 2008 at 76.5%. The objective is to improve the rate to 95% or more.

2 We are also highlighting Registered Surveyors who have submitted all or a number of their jobs which are perfect and have no query and/or clarification. The list for Jan 2008 is in Annex B. We thank these Registered Surveyors for the jobs well done and would like to convey our appreciation. Please continue with the good efforts. At the same time, we would encourage all Registered Surveyors to submit as many perfect jobs as they can. The recognition is to have their names listed with such number of their perfect jobs in Annex B.

3 Though the CS Notices on query-free jobs will cease reporting the query rate, we will continue the monitoring of the query rate (which includes clarification) as it is still very high at 70% in Jan 2008. Hence, we would again remind Registered Surveyors who submit jobs which resulted in query and/or clarification being raised that they need to put in more effort to attend to their jobs thoroughly and effectively before submission.
