PRACTICE CIRCULAR 2 OF 2013

To All Law Firms / Law Organisations

Paperless Titles Project

- 1. As part of our ongoing efforts to progress towards a fully electronic environment, I am pleased to announce that the Land Titles Registry (the Registry) has been working with the local financial institutions to dispense with the safe-keeping of documents of title by them.
- 2. Under the proposed arrangement with participating financial institutions, the Registry will not be printing the title documents upon the registration of instruments.
- 3. This means that the financial institutions will no longer have to safe-keep the title documents. They will save on storage and manpower costs. An added benefit is that it will no longer be necessary for them to apply for a replacement title since there will be no title document to be lost or destroyed. This will similarly benefit lawyers as they will avoid the risk of losing the title documents after collecting from the Registry. There is much cost savings by not having to apply for a replacement title document.

1st Phase: Pilot trial with DBS Bank Ltd

- 4. The Registry will conduct a pilot trial with DBS Bank Ltd commencing 3 June 2013. It will involve properties with computerised titles which are mortgaged or to be mortgaged to DBS Bank Ltd.
- 5. The Law Society has been briefed and consulted on this new initiative.

Lodgment Process for properties with paperless titles

- 6. Law firms will be required to submit an "Authorisation Form Suppressed Title" (AFS) when subsequent transactions are lodged at the Registry.
- 7. The AFS will be prepared electronically by the solicitors for the participating mortgagee and digitally signed by the mortgagee's authorised officer(s).
- 8. There are two variations of the AFS:-
 - (i) "Authorisation to Release" which is applicable when all mortgages in favour of a participating mortgagee are to be discharged (see sample at Annex A); and

- (ii) "Authorisation to Lodge" which is applicable when the mortgage(s) in favour of a participating mortgagee is still subsisting (see sample at Annex B).

Next phase: Pilot with other financial institutions/CPF Board

10. The Registry intends to extend the pilot trial to a few other financial institutions and/or CPF Board after the trial with DBS Bank Ltd before it is rolled out to all financial institutions. The necessary practice circulars will be issued when that happens.
