Computerisation of the records of HDB properties

I am pleased to announce that SLA has computerised its records for the following HDB estates:

- 1) Fernvale Vista I;
- 2) Fernvale Vista II; and
- 3) The Sundial

The Subsidiary Certificates of Title (SCTs) which will replace the leases as the documents of title will be generated by the Singapore Titles Automated Registration System (STARS) as and when there are new transactions registered.

Land Register searches via Integrated Land Information Service (INLIS)

Effective 16 March 2015, searches for SCTs issued for the above estates will be available via INLIS.

Grace Period for lodgment of instruments

A two-month grace period commencing from 16 March 2015 to 15 May 2015 will be given to all law firms / organisations to lodge their instruments in respect of the above estates manually over the counter.

Effective 18 May 2015, instruments in respect of the above estates are required to be lodged electronically via the STARS e-lodgment system.

List of HDB Properties with Computerised records

For your easy reference, a list of all HDB Properties with computerised records is shown at Annex A. This list will be updated as and when we progressively complete the computerisation of the records of each HDB estate. We will, in due course, make available this list on our STARS e-lodgment system and the INLIS websites.

Once the list is available on our two (2) websites, the Registry will issue the necessary practice circular to inform lawyers to check these websites prior to the lodgement of any HDB transaction.
