A Full Implementation of the Paperless Titles Scheme

We had in May 2016, informed the Association of Banks in Singapore that effective 1 June 2017, the Paperless Titles Scheme ("Scheme") will be extended to all properties charged or mortgaged to MAS-licensed financial institutions. Hence, SLA will no longer print the paper title documents upon the registration of transactions affecting properties charged or mortgaged to all MAS-licensed financial institutions. Lodgment of subsequent instruments against these titles will require an Authorisation Form – Suppressed Title ("AFS") which can only be digitally signed by duly authorised officers of the MAS-licensed financial institutions.

Please refer to <u>Annex A</u> for the list of entities who are participating or have applied to participate in the Scheme. If you act for any MAS-licensed financial institution not listed in Annex A, please advise your client to apply for an Administrator account in STARS eLodgment System ("ELS") and apply for the digital certificate from Netrust Pte Ltd as soon as possible in order not to delay the lodgment of any subsequent instrument that requires an AFS.
