## Pay-As-You-Use Subscription Mode for SIMRSN

1. With effect from 1 Jan 2005, use of Singapore Integrated Multiple Reference Station Network (SIMRSN) will be provided on following subscription modes:

2. All existing subscribers and new applicants are required to submit Application Form attached in Appendix A indicating the Account Type.

3. Users subscribing half-yearly can switch their account to Pay-As-You-Use or vice versa. Switching of subscription plan can only be done in the month of June for the subscription period of July to December. Base Fee of \$300 is chargeable for each time of activation of Pay-As-You-Use subscription. Application Form needs to be re-submitted by 1 June 2005 for switching of plan.

4. Users of all Account Types need to subscribe for a total of 12-month period.

5. For Pay-As-You-Use subscribers, usage charges will be deducted from Inter-Bank GIRO accounts twice a month upon users' acknowledgement of receipt of account usage summary report.

6. To serve our customers better, we will be reviewing the charges 6 months later
