DOING AWAY WITH LEVEL BOOK AND INCORPORATING LEVELING PAGES AS PART OF SK EFFECTIVE FROM 1 SEP 2007

Presently, Registered Surveyors are required to submit the Level Book (LB) for cadastral survey jobs which involve leveling works, such as surveys of 2.515 HWM boundaries, airspace lots and subterranean lots.

- We have accepted a staff suggestion to drop the LB as a survey document and to incorporate the leveling pages as part of the SK. I attach a sample of the level details recording page for your use. The level details recording pages shall be numbered consecutively after the cadastral survey recording pages. (Eg: If the cadastral survey recording pages are from SK99999-001 to 034 and there are 6 level details recording pages to incorporate, the level details recording pages shall be numbered from SK99999-035 to 040.)
- In the event of any new SK pages created for additional field work (either for cadastral or leveling work) carried out arising from query, etc, the page numbering for the new SK pages will continue from the last page number of the earlier survey. (Eg: If there are 3 new pages to be added on to the above example, the new pages will be numbered as SK99999-041 to 043.)
- The above will take effect for new jobs starting from 1 Sep 2007.
