CS DIRECTIVE ON CADASTRAL SURVEY PRACTICES – VERSION 3.4

The current CS Directive (Version 3.3) was last revised in Sep 2005.

2 We are pleased to inform you that it has been reviewed and updated to Version 3.4. In this revision, we have applied the following:

- i) Incorporated the directions from CS Circulars and Notices since Sep 2005;
- ii) Amended the previous version 3.3 on subsequent changes in practices;
- iii) Fine-tuned some of the items to make them easier to follow; and
- iv) Made relevant changes as suggested in some of your feedback.
