

**FEES CHARGEABLE UNDER
BOUNDARIES AND SURVEY MAPS (SINGAPORE LAND AUTHORITY FEES) RULES**

Since June 2001, SLA has maintained the fees chargeable under the Boundaries and Survey Maps (Singapore Land Authority Fees) Rules. With the rising operating costs, we are unable to continue with the current arrangement.

2 Effective 1 Oct 2010, the fee chargeable for "Survey of land" and "Strata survey" will be revised. The fee increase aims to find a balance between meeting part of the higher operating costs and achieving gradual cost recovery for these fee items. All other fees chargeable under the Boundaries and Survey Maps (Singapore Land Authority Fees) Rules remain unchanged. The new fee schedule is attached.
