SUBMISSION OF IRAS NOTIFICATIONS OF BUILDING NAMES

Presently, where applicable, Registered Surveyors are required to submit the IRAS notifications on Certification of Numbering for property addresses when requesting for activation of caveat lots or submitting jobs for approval. There is no requirement to submit the IRAS notifications for Building Names and the any submission is on a job to job basis or upon our requests.

Henceforth, where applicable, the IRAS notifications for Building Names are required to be submitted. In addition, if the job is for land lot survey, you have to enter the data in the "Building Name" and "Building Flag Source" fields in the data files. The name of building is to follow exactly the name approved by IRAS and the entry for "Building Flag Source" field is "I" (for IRAS). Most commercial, condominium and other major developments would have the approved building names. However, if there is no IRAS notification of the building name, please state this in your request / Remarks column of the Survey Report. A sample copy of 1st page of the notification is attached.
