### **TO ENHANCE REPRESENTATION OF DETAILS IN FIELD DETAIL SKETCH (SK)**

In cadastral survey submissions, all line-work of lot boundaries and details of existing structures picked up on site are shown in black on Detail Sketches ("SK"). Sometimes, the site may be overly-cluttered, making it difficult to distinguish between boundary lines and details when identifying encroachments.

2 At a recent Tea Session with Chief Surveyor, we have asked for your views to make the details more visible by showing them in red. We thank you for your robust responses and have evaluated your suggestions.

3 For all jobs submitted on and after 22 April 2013, you are required to continue to show all line-work in black but to highlight in yellow all encroachment details on the SK.

4 A sample SK showing this new requirement is attached at Annex A.
